

### I. Eligibility Criteria

- a) The agency should submit latest Income Tax return.
  - b) Bidder should submit their Individual/ company profile with previous 3 years audit report and turnover should be not less than Rs.20.00 lakhs in any one year in last five years signed by Chartered Accountant.
  - c) Bidders who are defaulter in payment which is due of any kind of revenue and contract amount to the BBMP are not eligible to participate in tender.
  - d) Only Bidders having Experience Running, supervision and maintenance of similar buildings and shops.(Previous experience certificate) shall be considered.
  - e) The successful bidder should submit Trade license for the shops from the concerned Authority within 30 days from the date of Letter of Acceptance.
- 2 Only the bidders who qualifies in technical evaluation (cover no. 1) they will be considered for opening the financial bids (cover no.2) for financial evaluation.
- 3 The Tender is a Two Cover Tenders System Consisting of
- a. **Technical Bid:** The Technical bid should contain EMD, details of technical,- financial and managerial capabilities with eligibility criteria as per the requirements.
  - b. **Financial Bid:** The financial bid should contain only the price bid. For such of those bidders, whose technical bids do not satisfy the eligibility criteria their financial bids will not be considered and the tenders will summarily be rejected.

### II. TERMS AND CONDITIONS

1. Bidder should be registered in e-Procurement website <https://eproc.karnataka.gov.in/>
2. The tender is purely through e-Procurement portal only (Two-cover system).


3. The bidders shall use the above mentioned shops only for trading eatables & Cafeteria. -
4. **As per the PWD norms rent fixed based on the valuation of the whole building is Rs 1285/day. i.e for one year is Rs 4,69,025/-.The minimum bid should not be less than Rs 4.70 lakhs /anum.**
5. Audited financial statements along with details including annual turnover, income and net cash accruals for the past 3 years.
6. Experience certificate in the relevant field.
7. The manual submission of Tenders and its documents will not be entertained (documents to be uploaded through e-Procurement portal only)
8. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).
9. **Only after e-payment through e-procurement portal the documents may be downloaded.**
10. **In addition to EMD 10% of the quoted /bid amount has to be paid in the form of Bank Guarantee in favor of Commissioner BBMP, before entering into agreement as a Security deposit.**
11. The successful tenderer should pay 12.5% of the total tender bid amount in one lump within 7 days from the date of entering to the agreement and Further payment has to be paid as per the below payment schedule.

In case if 12.50% of the bid amount / tender amount is not paid with in the stipulated time the BBMP is at liberty to forfeit the earnest money deposit and take further action to call for Re-tender by holding him responsible with risk and Cost for any losses incurred to the BBMP such tenderer shall loose his right to participate in retender again.

13. **The assigned work total duration is Five years only.**
14. No Joint Venture / Consortium are permissible
15. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
16. The tender is based on As is where is basis.
17. The bidder shall arrange electricity ,water ,security & other all amenities required for the maintenance of the shops.
18. The Successful bidder should maintain the shops in hygienic condition & use the shops only for eatables & cafeteria.
19. Bidders can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <https://eproc.karnataka.gov.in/>
20. The successful bidder should maintain a separate wet & Dry waste collection bins in shops premises.
21. Plastic covers should not be used. Use of plastic materials (covers/ Plastic posters/buntings/hand post) strictly prohibited in said property & shops surrounding area.
22. The successful bidder should maintain with all annual repairs/painting of the said shops with own cost and maintain regularly.
23. The BBMP officers have full authority on the said property to inspect and report on any irregularities.
24. The successful bidder should not cause any damage to the building. If so recovery will be made in security deposit & EMD.
25. Violations of any above mentioned conditions may lead to the cancellation of the tender.
26. The agency/Individual should handover the shops in good conditions after the completion of the contract period otherwise EMD & Security deposit will be forfeited.
