The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal . in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, K.R.Pura Division, BBMP office, K.R.Pura Bangalore – 560 036. Qualification of the Tenderer/ Eligibility criteria:


1. Any reputed Individual Company registered with Bruhath Bangalore Mahanagara Palike/BWSSB/KUWS&B/PRI/DPWD/ Railways/MI/Any State or Central Govt. Organisation are eligible to apply.
 2. No Joint Venture / Consortium is permissible.
 3. The Tenderer shall have executed and completed successfully in the last five years i.e. between 2011-12 and 2015-16 a single work of similar nature of value not less than the estimated value of Contract. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
 4. The Tenderer should have achieved in at least two financial years a minimum turnover not less than the Two times the amount put to tender.
 5. Work Completion Certificate for having completed at least one work of similar nature of value not less than the estimated value of Contract, certified from the Competent Authority not below the Rank of Executive Engineer shall be uploaded. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
- 6.1 All Tenderers shall provide the required information accurately and sufficient details in Section 3. Qualification information
- 6.2 To qualify for award of this contract, each Tenderer in his name should have in the last five years i.e. 2011-12 to 2015-2016
- (a) Achieved in at least TWO financial years a minimum financial turnover of Rs. 100.00 Lakhs (usually not less than two times the estimated annual payment under this contract) Notarized copies of Certificates issued by Chartered Accountant should be uploaded.
 - (b) Satisfactorily completion as a prime contractor for atleast one similar work to an extent of 50% of the cost of the work for all works more than Rs. 50.00 lakhs.
 - (c) Executed in any one year out of the last five years a minimum number of borewells of not less than 50% of the estimated numbers in any package.
- 6.3 Each Tenderer should further demonstrate:
- (a) Availability by owning the following key and critical equipment for this work:
 - (i) The tenderer shall have minimum three drilling rigs out of which at least one shall be owned by tenderer and other two may be on lease. In case of lease, Lease agreement to be executed on Rs. 200/- stamp paper with owners of the rig for a period of two years from the date of this tender notification. Notarized copies of valid rig documents such as RC Book, Fitness certificate upto date, tax paid receipt, Insurance paid receipt, and lease agreements should be uploaded.
 - (ii) One set of GPS Equipment for each rig.
 - (iii) The tenderer shall have one own RIG Registered with Karnataka Ground water authority. And shall have to produce FORM '7'A' in Original and valid.
 - (b) Liquid asset and/or availability of credit facilities of not less than Rs 100.00 Lakhs (Credit lines/letter of credit/ certificates from banks for meeting the fund requirement etc)
- 6.4 To qualify for a contract made up of this and other contracts for which tender are invited in this IFT the Tenderer must demonstrate having experience and resources to meet the aggregate of the qualifying criteria for the individual contracts.
7. The Tenderers shall upload the valid & present Certificate copies of PAN, VAT No., Service Tax Registration No. Contractor's Registration Pass Book for technical bid qualification eligibility.
 8. The Government authorities taking up construction work shall ensure all the contractors or any sub-contractor hired by the contractor get registration under section 7 of the Building and other construction workers' (Regulation of Employment and Condition of Service) Act, 1996. Similarly, all the construction workers shall get registration under section 12 of the Act.

9. If any bidder is quoting the rates less than the tendered amount, the bidder may scan the difference in amount DD & upload the same while submitting the tender.
10. The work shall be carried out as per the directions of the BBMP and Engineer in-charge.
11. Black Listed Contractors in Govt. Quasi Govt. Boards BBMP etc., are not eligible to quote, if found such bidders will be rejected.
12. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
13. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office. The Tender Document will form the part and parcel of the Agreement. Failing which the Tender will deem to be get cancelled.
14. The materials shall be got approved by the undersigned before Execute the work.
15. Further Details of the Work can be obtained from the Office of the Executive Engineer, BBMP, K.R.Pura Division, Bangalore-36 on all Working Days During office hours.
16. All the participants should produce all the original documents for verification whenever necessary.
17. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
18. The Taxes & Cesses will be Deducted as per the governing norms and certificate will be issued in favour of the Contractor from every running bill. Final bills of the contractor.
19. The rates quoted in the schedule shall be inclusive of all taxes applicable.
20. The Bruhath Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
21. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
22. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
