The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.
3. Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet ) within the date and time published in e-procurement portal. First Cover Tenders will be opened at prescribed time and date in the eprocurement portal, in the presence of the Tenderers who wish to attend at the Office of the Executive Engineer, Project South BBMP. 1st Floor 9th Main, 9th cross, Jayanagar 2nd Block, Bangalore



3. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
4. The Tender will remain valid for **90 Days** from the Date of Opening of bid.
5. The Work shall be commenced with all Men and Material within 7 days from the Date of Work Order issued, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tender & his EMD will be forfeited.
6. Submission of EMD is mandatory and which will be forfeited if the tenderer is not quoted is rates / not participated.
7. Refund of EMD will be only after the completion of the defect liability period.
8. The Bruhat Bangalore Mahanagara Palike Tender document is part and partial of the agreement. **The successful tenderer** will have to execute agreement with BBMP without assigning any reasons otherwise his EMD will be forfeited.
9. If the bidder quotes the lesser amount when compare to the tender amount, difference amount has to be paid through D.D. in favour of Commissioner, BBMP before execution of agreement.
10. Any reputed Individual/ company registered with BBMP/CPWD/ KPWD/ Railways/ MES or any State Government Organization are eligible to apply for the work mention in SI No1 of above mentioned Table.
11. The agency should be registered with I.T, E.S.I, P.F, Labour Department, Police department (ISD), GST registration and other statutory authority of Government of Karnataka are eligible to apply for the security work. (applicable for SI. No. 1 to 2 )
12. No Joint Venture / Consortium are permissible.
13. Bidders/Contractors Should attach all the Scanned copies of certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which, the bid will not be considered. The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
14. **Rates shall be quoted in Tender Schedule-B in the e-Procurement portal only.**

15. The rates quoted should include all taxes such as service tax, GST & all other statutory payments as applicable during the period of tender.
16. The commissioner decision is ultimate.
17. **Conditional tenders will not be accepted.** As per Govt order No.LD/300/LET/2006, Dated:18/01/2007 and Addl. Commissioner (Finance) No.BBMP/CAO/PR/07-08, Dt:03/08/07 the building construction labourers welfare cess (1% of Est. Cost) will be deducted from the Building and other construction works in every running bill and also in the final bill of the Contractor.
