- The Executive Engineer (Shanthinagar Division), BBMP, Bangalore on behalf of the Commissioner, BBMP invites tenders from eligible Contractors registered in Bruhat Bangalore Mahanagara Palike or equivalent registration with CPWD / KPWD / Railways / MES/National Highway or any State Government Organizations for the construction of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz <https://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract (Standard Tender Document – KW1 and KW2).
- Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka from 06-02-2019
- Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
- Tenders must be submitted online through e-procurement portal on or before 16.00 hours on 18-02-2019 and the opening of tenders will be on 20-02-2019 at 16.00 hours (If possible).

#### Eligibility Criteria:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. Works reserved for SC / ST candidates is strictly prohibited for SC/ST only.
4. SC / ST candidates should upload the documents regarding the caste.
5. The Tenderer shall have executed and completed successfully in the last five years i.e., between 2011-12 to 2015-16 a single work of similar nature of value not less than the estimated value of contract. In support of this, the Tenderer shall furnish a work completion certificate duly certified by the Competent Authority along with Technical Bid.
6. The Tender shall have achieved in at least two financial years a minimum of turn over not less than the Two times the amount put to tender.
7. Work completion certificate for having completed at least one work of similar nature of value not less than the estimated value of contract certified from the competent authority not below the Rank of Executive Engineer shall be uploaded. The work completion certificate shall mention the nature of work, items of work executed and the date of commencement and date of completion of the work.
8. The tenders shall upload the valid and present certificate copies of PAN, VAT No., service Tax Registration No, Contractor's Registration pass book for technical bid qualification eligibility.
9. If the rate quoted by the Contractor is below the approximate value of the work as mentioned in the column 4 of the above table, the contractor should pay the difference of amount in favour of The Executive Engineer Shanthinagar Division, BBMP. In form of DD or Pay order or FDR (Fixed deposit receipt) or Bank Guarantee before entering into Agreement. The same will be refunded only after satisfactory completion of the work.
10. The work shall be carried out as per the directions of the BBMP and Engineer-in-charge.
11. Black listed contractors/in govt/Quasi govt/boards/BBMP etc., are not eligible to quote, if found such tenders will be rejected.
12. The successful Tenderers shall execute an Agreement within 7 days from the date of Receipt of intimation from this office, The Tender Document will form the part and parcel of the agreement, failing which the tender will deem to be get cancelled.

13. The material shall be got approved by the undersigned before execute the work.
14. Further details of the work can be obtained from the office of the Executive Engineer, Shanthinagar Division, 9<sup>th</sup> Floor, P.U. Building, M.G. Road, Bangalore -560 001. on all working days during office hours.
15. All the participants should produce all the original documents for verification whenever necessary.
16. Certified Xerox copies of the documents shall be enclosed along with the tender, failing which the tender will be rejected.
17. The Taxes and Cesses will be deducted as per the governing norms and certificate will be issued in favour of the Contractor from very running bill / final bills of the contractor.
  - a. The rates quoted in the schedule shall be inclusive of all taxes applicable.
  - b. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
  - c. The tender will remain valid for 90 days after the deadline date for tender submission.
  - d. The work shall be commenced with all men and machinery within 7 days from the date of work order, failing which it would be presumed that the successful tenderer is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
  - e. Conditional tenders will not be accepted.
