Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, Mahadevapura Division, BBMP office, Mahadevapura Bangalore - 560 048. ### **TERMS & CONDITIONS:**

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2015-2020 should be enclosed with the tender documents.
4. The Tender Document will form the part and parcel of the Agreement.
5. As per Special. Commissioner (project) Circular No.ION/PR/(1)/08/07-08, Dt:16/10/07, and Engineer-In-Chief Order No: EIC/EC/PR/606/07-08, dated: 24/9/2007. The following conditions are stipulated in the tender, "The amount quoted by the tenderer is less than the tender amount, such tenderer shall upload the difference amount DD at the time of submitting tender in Online in Financial bid documents. And handover the same Demand Draft to the office before signing the Agreement, in the form of DD in favour of Executive Engineer( Mahadevapura), B.B.M.P. And The EMD Bank Guarantee also to be uploaded and should be submitted to the Office of the Executive Engineer, BBMP, Mahadevapura Division before opening the Technical Bid, and failure to comply the said conditions, the tender will be rejected.
6. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
7. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
8. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
9. Tenderer who have the works Pending with them will not be entertained.
10. The EMD and FSD amount will be returned after successful completion of Two year.
11. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason there of.
12. The rates quoted in the schedule shall be inclusive of all taxes applicable.
13. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
14. The successful Tenderer shall pay the Difference Cost if within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
15. The successful Tenderer shall execute an Agreement within 30 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
16. As per Government order no. LD 300/LET/2006, dt:18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.

17. Sub-Letting of work is prohibited.
18. The defect liability period for Civil works & Asphalt works maintenance period is Two year from the date of final bill. The E.M.D and S.D. will be refunded only after the defect liability period.
19. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H ( IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
20. For Asphalt works i.e., BM and BC those who own their hot mix plant 40-60 TPH & mechanical paver only shall apply.
