2. The Consultant will be selected under Least Cost Selection (LCS) of KC-8 standard document.

4. Tenders must be accompanied by earnest money deposit which will pay online through e-Procurement portal.

- I. Detailed Topographical Survey
- II. SWD inventory and SWD condition survey, levelling surveys & soil investigations
- III. Study of inflow of storm water from catchment area
- IV. Existing SWD mapping – cross section detailing & strip plan with entry exit mapping with reference to the Master Plan of SWD
- V. Identification of existing utility lines on topographical survey drawing.
- VI. Design of alignment of SWD
- VII. Water flow / Sewage flow evaluation and design of SWD
- VIII. Proposal for Relocation of utilities
- IX. Storm Water drains designs
- X. Detailed design of Bridges /Culverts with plan, levels, etc.,
- XI. Cost Estimation and Bill of Quantities.
- XII. Action plan for implementation and completion of project.
- XIII. Power Point Presentation, meetings and discussions on the project at various levels including presentation in front of TAC of BBMP
- XIV. Preparation of Technical Specifications and tender documents including design parameters for Retaining walls, bridges as the case maybe.
- XV. Review of Technical documents if needed, revise and finalize the optimum engineering project concept.
- XVI. All activities related to field studies, design and documentation shall be done as per the latest guidelines / circulars of MoRT&H for bridges, CPHEEO guidelines, IRC (SP: 50:2013) guidelines for urban drainage, National Disaster Management guidelines, Management of Urban Flooding, RMP of Bangalore city and relevant codes / publications of the latest standards. For aspects not covered, international standard practices, such as, British and American Standards may be adopted.

2. Eligibility Criteria :

- a) The interested consultancy firm should have a minimum annual turnover of .(Rs.110 lakhs for pkg no.1, Rs.98.68 lakhs for pkg No.2, & Rs.78.80 for pkg.3)in any two financial years from the last five financial years. The firm should enclose the copy of the Balance sheet duly signed by the Chartered Accountant. The vouchers of service tax paid must be included along with the certificate issued by Chartered Accountant.
- b) The interested consultancy firm should have completed DPR for any project of similar nature not less than 50% of the project cost shown in the tabular column above (Similar nature means the work related to SWD in any of city of India not less than 100 sq kms) or canal work related irrigation projects. The Consultant should have good experience in the preparation of Design, Estimation in the field of Storm Water / Rainfall and Flood control system & city hydrostatics, disaster management.
- c) The interested consultant should produce the work completion certificate should be obtained duly signed from an officer not below the rank of Executive Engineer and countersigned by SE/CE as the case maybe.
- d) Consultants must establish an office in Bangalore with necessary infrastructure on award of work.

3. Qualification information :

- a) No joint ventures are allowed.
 - b) The Firm Should be registered in any of the Government organisation in current Period.
4. The tender comprises two covering system of (i) Technical Bid and (ii) Financial Bid. The Technical bid containing details of their capability to undertake the tender and scope of service to be carried out, which will be opened first and financial bid contains Bill of quantities (BOQ), which will be opened only if the Consultant is found to be qualified to execute the tendered work. (The intending bidders shall furnish the relevant experience certificates duly signed by the competent authority not less than the rank of Executive Engineer and countersigned by SE/CE as the case maybe.)
 5. Tender documents may be downloaded from Government of Karnataka e-Procurement website <http://eproc.karnataka.gov.in/> under login for Contractors. Aspiring consultants who have not registered in e-procurement should register before participating through the website <http://eproc.karnataka.gov.in/>.
 6. Consultant can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <http://eproc.karnataka.gov.in/> after submitting the EMD and tender processing fee in the form of e-payment. EMD will be refunded only after acceptance of successful bidder.
 7. Consultants should attach all the Scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered.
 8. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
 9. Latest income tax paid certificate (Challen) from the income tax department.
 10. Any effort by the consultant to influence the client in the bid evaluation, bid comparison or contract award decision results in rejection of the consultants bid.


