The Executive Engineer (Road Infrastructure – TEC Division), BBMP, Bengaluru invites Tenders from eligible Tenderers on Turnkey, Lump Sum, Fixed Price, No Variation Basis based on Tenderer's own Design on the basis of Parameters fixed by the BBMP (Alternate Proposal is permitted and is limited to only one) for the Construction of Works detailed in the table below. The Alternate Proposal submitted by the Tenderer (along with his Specific Experience) as part of Technical Bid shall conform to the Relevant Indian and International Standards satisfying the Key Parameters fixed by the BBMP and shall be approved by the BBMP. The Tenderers are advised to note the Minimum Qualification Criteria specified in Clause 3 of the Instructions to Tenderers to qualify for Award of the Contract as per Standard Bidding Document uploaded in the e – Procurement Portal.

4. Tenders must be accompanied by Earnest Money Deposit specified for the Work in the table below. Earnest Money Deposit will have to be in any one of the forms as specified in the Tender Document and shall have to be valid for 45 days beyond the Validity of the Tender.


