### Eligibility criteria:

1. No Joint Ventures / Consortiums are permissible.
2. The consulting firm shall have experience of similar nature of work in last Five years i.e. between 2011-12 and 2018-19 of project cost not less than 80 % of Amount put to tender. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not less than the rank of Executive Engineer along with Technical Bid.
3. Achieved in at least two financial years a minimum turnover not less than two times the amount put to tender.
4. Present net worth should be two times the amount put to tender. In support of this, bidder should furnish certificate certified by the Chartered Accountant.
5. Latest income tax paid certificate (Challan) from the income tax department.
6. The bids are to be submitted in the electronic tendering system only. The tender comprises single/two cover systems Technical Bid and Financial Bid. The bid containing details of their capability to undertake the tender and scope of service to be carried out, this will be considered.
7. The Bidder should furnish the list of manpower, equipments and machineries possessed by him as per the tender documents.
8. Bidder should attach all the scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered.(also all scanned copies should be visible and should have clarity)
9. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
10. Corrigendum / modifications / corrections, if any, will be published in the website only.
11. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.
12. The Bruhat Bangalore MahanagaraPalike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
13. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
14. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
15. Conditional tenders will not be accepted.


