1. The Executive Engineer (Bommanahalli Division), BBMP, Bangalore. invites tenders from eligible contractors registered in Bruhat Bangalore Mahanagara palike or equivalent registration with CPWD / KPWD / Railways / MES / National Highway or any state Government Organisations for the execution of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz <https://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract (standard Tender Document – KW2).
2. Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka from : **03.05.2019 to 06.05.2019**
3. Tenders must be accompanied by earnest Money deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
4. Tenders must be submitted online through e-procurement portal on or before 1600 hours on :**14.05.2019** And the opening of tenders will be as per the e-procurement portal guidelines.

TERMS & CONDITIONS:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. Contractors participating for works reserved for SC/ST should upload caste certificate issued by competent authority.
3. If the Contractor / Agency intended to quote less than the estimated cost the contractor shall put an DD / Pay Order for the tender difference amount quoted drawn in favour of Commissioner, BBMP A/c Executive Engineer, Bommanahalli Division, BBMP, Bangalore payable at Bangalore from nationalized / scheduled bank. The Tender Difference Amount DD should be produced on a date as specified in calendar of events at the office of the undersigned to Account Superintendent (Bommanahalli Division). If the contractor fails to produce the Tender Difference Amount his tender will be disqualified. The DD for difference amount shall not be accepted after completion of the specified time Schedule.
4. No Joint Venture / Consortium is permissible.
5. The Tender Should be accompanied by the Registration certificate.
6. The Competent authority of the Bruhat Bangalore Mahanagara Palike reserves the right to accept or reject any or all the tenders without assigning any reason thereon.
7. The Income VAT and K.S.T. as applicable will be deducted from every running and final bill of the contractor.
8. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
9. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
10. Tenderer who have the works pending with them will not be entertained.
11. The work shall be carried out as per the directions of the BBMP Engineer in-charge
12. Tender capacity of the Contractor will be based on qualification information vide clause of the Instructions to the Contractors.
13. The defect liability period for completed works is as shown in from the date of final bill.
14. (a) The E.M.D and S.D will be refunded only after Completion of the defect liability period.
(b) The F.S.D amount should be 7.5% of the project cost as applicable.
15. Further particulars can be obtained from the office of the Executive Engineer, Bommanahalli Division, Begur main road, Bommanahalli, Bruhat Bangalore Mahanagara Palike, Bangalore-68, during the working days between 10.00 A.M to 5.30 P.M
16. The prevailing S.R. Rates of Bitumen / Cement / Steel at the time of opening of tenders consider as per Para(4) of general notes to the S.R of Bangalore circle for the year 2016-17.
17. 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No.LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No.BBMP/CAO /PR/6/07-08, Dated: 3.8.2007.

18. Road cut Portin: During the maintenance period if any other agency cut the road for laying BWSSB/OFC/BESCOM & other agency the contractor has to re do the road cut portion. If necessary permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.
19. All the participants should produce all the original documents for verification whenever necessary.


