The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract (Standard Tender Documents-KW-1 & KW4).

2. Tenders must be submitted online through e-procurement portal on or before 16.00 hours on 15.06.2019.
3. Technical Bids will be opened on the website <https://eproc.karnataka.gov.in> in the Office of the Executive Engineer (East- Project) on 17.06.2019 at 16:30 hours.
4. The bids are to be submitted in the electronic tendering system only. The tender comprises two cover systems Technical Bid and Financial Bid. The bid containing details of their capability to undertake the tender and scope of service to be carried out, this will be considered.
5. Tender documents may be downloaded from, Government of Karnataka e-Procurement website <http://eproc.karnataka.gov.in/> under login for contractors.

6. Contractor can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <http://eproc.karnataka.gov.in/> after submitting the EMD and tender processing fee in the form of e-payment. EMD of the unsuccessful bidders will be refunded only after issue of LOA of successful bidder.
7. Bidder should attach all the scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered. (also all scanned copies should be clearly visible and attested)
8. Any effort by the bidder to influence the client in the bid evaluation, bid comparison or contract award decision results in rejection of the bid.

A successful bidder will have to execute an agreement with Executive Engineer (Project) East Zone BBMP, Bengaluru within 20 days upon receipt of intimation along with performance Security as per contract price in form of Bank Guarantee obtained from a Nationalized Bank / Scheduled Bank payable at Bengaluru. The work shall be commenced with all earnestness within seven days from the date of issue of work order, failing in such cases the performance security will be forfeited which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency.
