Tender documents may be downloaded through Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in> under login for Contractors: After login to Contractors, Please scroll down to the right side bottom to see List of Tenders, Please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.
3. Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. First Cover Tenders will be opened at prescribed time and date in the eprocurement portal, in the presence of the Tenderers who wish to attend at the Office of the Executive Engineer, Project South BBMP. 1st Floor 9th Main, 9th cross, Jayanagar 2nd Block, Bangalore

Eligibility criteria:


1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. The Tenderer shall have executed and completed successfully in any one financial year during block period of previous five financial years. i.e. between 2014-15 and 2018-19 a single work of similar nature of value not less than 25% value of amount put to tender In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
4. Achieved at least two financial years a minimum financial turnover not less than one times the estimated annual payment under this contract in all civil Engineering works in last 5 years.
5. The bidder must submit balance sheets for proof of having annual turn over not less than twice the amount put to tender in any two of the previous five financial years, which shall be duly certified by a Chartered Accountant.
6. Latest income tax paid certificate (Challan) from the income tax department.
7. The tender is of Single cover system.
 - i) Rates shall be quoted in Tender Schedule – B (Financial Bid) in the website itself.
8. The Bruhat Bangalore Mahanagara Palike Tender document (PWG 65) is part and parcel of the agreement. The successful tenderer will have to execute agreement as present with BBMP within seven days of receipt of intimation.
9. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
10. The validity of tender is 3 months from the date of opening of tender.
11. **Conditional tenders will not be accepted.** As per Govt order No.LD/300/LET/2006, Dated:18/01/2007 and Addl. Commissioner (Finance) No.BBMP/CAO/PR/07-08, Dt:03/08/07 the building construction labourers welfare cess (1% of Est. Cost) will be deducted from the Building and other construction works in every running bill and also in the final bill of the Contractor.
12. GST of 12% shall be paid to the tendered amount separately as per the Govrt letter No.PWD 65 RDF 2017 dt:11/10/2018
13. The work should be commenced with all men and machinery within seven days from the date of work order, failing which it would be presumed that he is not interested in his work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
14. After opening of the tenders, before signing of the agreement, tenderer shall be asked to give a Demand Draft/Bank Guarantee for difference of amount between the quoted rates and the estimated cost, if the rates quoted are less than the estimated cost.
