In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not less than the rank of Executive Engineer along with Technical Bid.
3. Consultants should have achieved in at least each of two financial years a minimum financial turnover of 250 Lakhs from 2014-15 and 2018-19..
4. Should have completed preparation of Detailed Project Report for roads a length of 200 kms in last five Years (2014-15 and 2018-19)
5. Adequacy of the Proposed Work Plan and Methodology in response to the TOR - Site appreciation, Project Time Scheduling
6. Established office and well equipped NABL Accredited Laboratory.
7. Qualification and Competence of the Key Professional Staff for the Assignment.
8. Experience in region & language Knowledge in Kannada and English Language
9. The bids are to be submitted in the electronic tendering system only. The tender comprises single/two cover systems Technical Bid and Financial Bid. The bid containing details of their capability to undertake the tender and scope of service to be carried out, this will be considered.
