1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.

2. The Service providing agency should be registered with I.T, E.S.I, P.F, Labour Department or other statutory authority of Government of Karnataka.
3. If The Tenderer quoted less than the Current minimum wages including all taxes as applicable time to time gets disqualified and his EMD will be forfeited.
4. No Joint Venture / Consortium are permissible.
5. The Tenderer shall have executed and completed successfully in the last Five years i.e. between 2016-2017 and 2018-2019 a single work of similar nature of value not less than 50% of Amount Put to Tender. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority.
6. The Tenderer Should not incurred any loss in more than a year during the last 3 years ending 31st March 2018 i.e. between 2016-2017 and 2018-2019. For reference submit Three years Audited statements duly certified by Chartered Accountant (Three Forms) and the Annual returns filed, to be furnished through portal.
7. Shall have minimum Annual turnover not less than two (2) times the amount put to tender during one of the last five financial years. i.e. between 2014-2015 to 2018-2019 certificate certifying the turnover from Chartered Accountant to be furnished through portal
8. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC) as per Chief Finance Officer, BBMP Circular No.CFO/31/Training/2010, dated: 03-09-2012.
