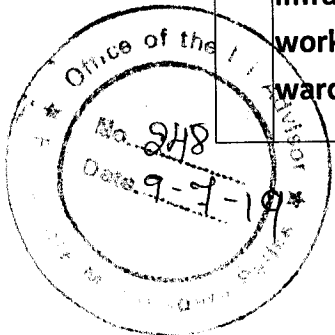

1. The Executive Engineer, Project South, BBMP, invites tenders on behalf of the commissioner, BBMP, Bengaluru from eligible Tenderers for the construction of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz., <https://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
2. Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka.
3. Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
4. Tenders must be submitted online through e-procurement portal on or before **16.00** hours on **13.08.2019** and the opening of tenders will be as per the e-procurement portal guidelines.

Eligibility Criteria:

1. The Tenderer shall have executed and completed successfully a single similar nature of work of value not less than 50% value of amount put to tender in any one financial year during block period of previous five financial years. i.e., between 2014-15 and 2018-19. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, the Date of Commencement and Date of Completion of the work.
2. Each tenderer in his name should have achieved in at least two financial years a minimum turn over (In all classes of civil engineer construction works only) of not less than two times the estimated annual payments in the last five years i.e., 2014-15 and 2018-19.
3. Tenderer shall furnish list of Equipment and Machineries possessed by him / her.
4. The bidder shall have Present net worth not less than 75% of amount put to tender.
5. The bidder shall have achieved at least two financial years a minimum financial turnover not less than 2 times the estimated annual payment under this contract in all civil Engineering works in last 5 years. The bidder shall submit balance sheets as proof of having annual turn over as above, which shall be duly certified by a Chartered Accountant.
6. The bidder must submit line of Credit for an amount equal to estimated cash flow for 3 months in peak construction period issued by Nationalized/ Scheduled Bank of original, for the tendered work.
7. The bidder shall submit latest income tax paid certification from the income tax department.
8. ISO Certification for the equipment manufacturing, marketing, servicing and establishment should be uploaded.
9. GST of 12% shall be paid to the tendered amount separately as per the Govrt letter No.PWD 65 RDF 2017 dt:11/10/2018.

General Conditions.

Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>.

4. The Tender will remain valid for **180 Days** from the Date of Opening of Financial bid.
5. The Work shall be commenced with all Men and Material within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.

7. Any reputed Individual/ company registered with BBMP/CPWD/ KPWD/ Railways/ MES or any State Government Organization are eligible to apply.
8. No Joint Venture / Consortium are permissible.
9. **The Tender is a Two Cover Tenders System.**
10. **Only bidders who qualifies in technical evaluation (cover no. 1) are eligible for opening the financial bids (cover no.2) .**
11. The bidder must submit line of Credit for an amount 30% of the amount of contractor, issued by Nationalized/Scheduled Bank of original, for the tendered work.
12. The intending tenderers shall furnish a cash flow chart on month basis for the entire period of execution of the work.
13. The bidder must submit Provisional programme for completion of various items of work.
14. Bidders/Contractors Should attaches all the Scanned copies of technical documents/certificates pertaining to their eligibility criteria mentioned.
15. Above in the website itself, failing which, the bid will not be considered. (Technical Bid). The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
16. Rates shall be quoted in Tender Schedule-B (Financial Bid). In the website itself.

21. Conditional tenders will not be accepted. As per Govt order No.LD/300/LET/2006, Dated:18/01/2007 and Addl. Commissioner (Finance) No.BBMP/CAO/PR/07-08, Dt:03.08.2007 the building construction labourers welfare cess (1% of Est. Cost) will be deducted from the Building and other construction works of every running and final bill of the Contractor.
22. Any Dispute between tenderers and Bruhath Bangalore Mahanagar Palike, Bangalore the judicial decision will be decided within the jurisdiction of courts in Bangalore City Limits Only.
23. No Escalation of prices will be allowed under any circumstance.


