In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority.

Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC) as per Chief Finance Officer, BBMP Circular No.CFO/31/Training/2010, dated: 03-09-2012.


13. The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
