TERMS & CONDITIONS:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations having VALID ELECTRICAL INSPECTORATE LICENSE of appropriate Class are eligible to apply.
2. Certified Xerox copy of the valid Registration Certificate issued by BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations and should be enclosed with the tender documents with valid electrical inspectorate license.
3. The Tender Document will form the part and parcel of the Agreement.
4. Within 20 days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a security deposit in any of the forms given below for an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause 25.5 of ITT & Clause 44 of the conditions of contract for all works Difference Amount and Security Deposit in the form of FDR/Banker's cheque/Demand draft,/Pay Order in favour of Executive Engineer (Ele), Dasarahalli zone B.B.M.P. Security deposit for an amount equivalent to 5% of the contract price of the works reserved for SC/ST category will be Deducted from every running bill / final bills of the contractor:
5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
6. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
7. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
8. The EMD & SD amount will be returned after successful completion of ONE year.

9. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
10. The Tenderer shall give one year Guarantee for the instruments and maintain for one year and replace such parts, fused out, burnt out and defective parts thereon at free of cost.
11. The contractor belonging to the Scheduled Castes or Scheduled Tribes shall be domicile of the State of Karnataka for more than 10 years. And certified copy of the same (certificate/document) shall be uploaded at the time of Tender/agreement.
12. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
13. Successful Contractor who is not registered in BBMP shall Register with BBMP before entering in to Agreement for Contract failing which the tender shall be rejected.
14. The Successful Bidder shall have an office within BBMP limits as the maintenance of Electrical installation in BBMP buildings/street light maintenance within the defect and liability period shall be carried out without fail in case of non burning/working of electrical fixtures and repair of Electrical Installation of the respective work. And the Successful Bidder who is residing outside Bengaluru shall submit the details of office existing in BBMP limits before entering into Agreement for Contract failing which the tender shall be rejected.
15. The Income Tax at the rate of 2.00%, SD at 5%, LWC at 1%, CBF at 0.1% and GST as per norms will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor:
16. The rates quoted in the schedule shall be inclusive of all taxes applicable.
17. The work shall be carried out as per the directions of the BBMP Engineer in-charge of work.
18. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
19. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
20. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
21. The sample & make shall be got approved by the undersigned before Executing the work.
