CONDITIONS:

- 1 The Tender Notification along with Blank Tender Form will be accessible in the website of GOK e- Procurement Platform (<http://eproc.karnataka.gov.in>) website.
- 2 Tender documents may be downloaded from Government of Karnataka e-Procurement website <http://eproc.karnataka.gov.in> under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in> or contact e-Procurement Helpdesk at 080 – 22485867 / 22485927.
- 3 The Tender will remain valid for 90 Days from the Date of Opening of Tender.
- 4 The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
- 5 The Successful tenderer will have to execute an agreement with BBMP within seven days of receipt of intimation, failing which his tender will be rejected
- 6 The Work shall be commenced with all Men and Material within 3 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.
- 7 The control room with Labours and necessary equipments/ materials should be set up and run 24X7 for 1 year.
- 8 As per Goyt. Order, No.LD 300/LET/2006, Dated: 18.07.2007, 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board

- 9 The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Bidders to qualify for award of the contract (Standard Tender Document – KW-3).
- 10 Any Corrigendum / Modification will be notified in the Notice Board of the Undersigned.
- 11 The BBMP reserves the right to accept/reject any or all tenders without assigning any reasons what so ever.
- 12 The Work shall be commenced with all Men and Machinery within 3 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 13 Within 7 days of receipt of the Letter of Acceptance, the successful Tenderer shall deliver to the Employer a Security Deposit in form of DD drawn in favour of Commissioner, BBMP A/c Executive Engineer, Byatarayanapura Division, BBMP, Bangalore payable at Bangalore from nationalized / scheduled bank for an amount equivalent to 5% of the Contract price. Otherwise Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 14 Further particulars can be had from the office of the Executive Engineer, Byatarayanapura Division, BBMP during the working days between 10.00 A.M. to 5.30 P.M.
- 15 The bidder should give an undertaking that he/she would abide by the provisions of employees provident fund and shall remit PF of labourers to the respective PF offices or else BBMP have the right to deduct the PF amount from the work bills and remit the same to the respective PF Offices
- 16 The contractor shall quote the rates inclusive of PF and all applicable taxes. As per the applicable rate as issued by the PF department from time to time in respect of employee employed by the contractor (as per section (6) of the Act. details of contribution which shall be paid the employer towards his share as also deduction from the employee's wages within 15 days from the close of every month with the concerned PF Commissioner) and shall satisfy the EPF and MF Act, 1952 and compliance of the same. In default by the contractor, deduction from any amount payable to the contractor under any contract is permissible and such amount paid by the commissioner BBMP can also recovered from the contractor as provided under sec. 421 of / refunded by / BBMP against documentary evidence.
- 17 The DD for Tender difference Amount should be produced before executing the agreement.
- 18 The Successful bidder shall give an undertaking that he/she would abide by the provisions of employees provident fund act.
- 19 Remittance towards PF shall be commensurate with the labour component of the work involved.
- 20 The bidder shall remit PF of labourers to bidder permanent PF code only.
- 21 The contractor shall quote his rates inclusive of all applicable taxes, levies, duties and cess, building worker welfare cess as per the latest notification of GOK and GOI prevailing on the date NIT.
- 22 The bidder should maintain register of labours deployed and wages paid for the workers and shall produce the documents whenever called for by the competent authority. Remittance towards PF shall be commensurate with the labour component of the work involved.
- 23 As per circular No. ಮು.ಅ(ಯೋ-1)ಪಿ.ಆರ್/11/15-16 ದಿನಾಂಕ:22.05.2015ರಂದು ಮತ್ತು ಅಭಿಯಂತರರು (ಯೋಜನೆ-1), ಬೃಹತ್ ಬೆಂಗಳೂರು ಮಹಾನಗರ ಪಾಲಿಕೆ ರವರು All intending applicants who are already registered other than in BBMP I.e, Government to organizations, should compulsorily get themselves registered in BBMP before executing agreement.
- 24 GST will be paid to the tendered amount separately only for 2018-19 schedule of rates and for GST is included in other than 2018-19 shedule of Rates.
