(Technical Bid). The original documents should be produced for verification at any stage of tender process as and when sought failing which, the bids are liable for disqualification.
  - ii) Rates (Financial Bid) shall be separately quoted in the website itself.
5. EMD (as applicable) paid in the form Online system as per e-Procurement portal failing which the tenders will not be considered. For those bidders whose Technical bids do not satisfy the eligibility criteria, their financial Bids will not be opened.
