- 1 The Executive Engineer, Rajarajeshwari Nagara Division, BBMP, Bangalore invites tenders from eligible Contractors registered in Bruhat Bangalore Mahanagara Palike or equivalent registration with CPWD/ KPWD/ Railways/ MES/ National Highway or any State Government Organisations for the construction of work detailed in the table below. The tenderers may submit tenders for work given in the table through e-procurement portal of the Government of Karnataka (viz <https://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract **(Standard Tender Document – KW 4)**
- 2 Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka from **02.11.2019**
- 3 Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 90 days beyond the validity of the tender.
- 4 Tenders must be submitted online through e-procurement portal on or before **16:00** hours on **20.11.2019** and the opening of tenders will be as per the e-procurement portal guidelines.

- 1 Aspiring Bidders / Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>
- 2 Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
- 3 Certified Xerox copy of Valid Registration Certificate issued by B.B.M.P for the Block period of 2016-2020 should be produced by the qualified Contractor at the time of Agreement
- 4 All the information required for Bids must be filled and submitted online

- 7 Conditional tenders will not be accepted.
- 8 The contractor has to make own arrangements for procurement of all materials. There is no departmental supply of materials. Contractor should Procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control.
- 9 The contractor is not eligible for submission of application for tender form if he has not participated tenders after purchase of the tender document continuously for the three times.
- 10 Sub-letting of work is prohibited.
- 11 Any corrigendum/ Modification will be notified in the Notice Board of the undersigned.
- 12 As per the Government Order No: LD 300/LET/2006, Dt. 18.07.2007 LWC 1% of the bill amount will be deducted and remitted to Karnataka State Building & other construction Employees Welfare Board.
- 13 As per the Government Order No.(CAO/Budget:647/2009-10 Date:24.05.2010) Deduction of Royalty form the bills of the Contractors working in Civil works, if the Contractor proves that aspect of the matter then the Department/ work executing agency cannot recover or deduct any royalty from the bills of the contractor, if the documents/ MDP's are produced from the quarry lease holders or Private quarry owners in this regard then the contractor is not liable to pay the royalty charges
- 14 Necessary taxes and other deductions will be made from Contractor bills.
- 15 The Successful bidder will have to execute an agreement with BBMP within 7 days of receipt of intimation, failing which his tender is liable to be rejected.
- 16 The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
- 17 The tenders should have to produce contractors registration book issued by the concerned authority for procurement of tender documents. Applicant should submit proof registration, latest Income tax clearance Certificate, obtained from the concerned Department and to submit financial Turnover balance sheet for the last 3 years duly attested by the Chartered Accountant while submitting the request for application for the Tender Schedules, otherwise the application will be rejected.
- 18 The work should be commenced with all earnestness within 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tenderer.
- 19 If the rate/ amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer submit the difference amount at the time of agreement in form of DD in favour of the Commissioner, Bruhath Bangalore Mahanagara Palike. This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.
