In exercise of powers conferred under Section 24 of the Disaster Management Act, 2005 to Commissioner, BBMP through Order No: RD 158 TNR 2020 dated 14-04-2020 of Government of Karnataka and in view of the proceedings of the review meeting held under the Chairmanship of Commissioner, BBMP on the status of BBMP COVID-19 War Room dated 01-05-2020, the following order is issued for compliance.

BBMP COVID-19 War Room has been established and is already functional as Single Point Interface for all departments and functions at BBMP for all COVID-19 related activities. All reports, monitoring, and compliance shall be duly submitted and updated as per the schedule issued by the undersigned without any delay. It is pertinent to note that all correspondence with regard to COVID-19 related activities or reporting shall be routed through the BBMP COVID-19 War Room.

By the Order of the undersigned dated 20-03-2020, the BBMP COVID-19 War Room is the Strategic Operations Command Center for COVID-19 Crisis Management and shall have all the appropriate applications, technological interventions and their developments, integration and effective management of single city-wide technology platform to onboard all the stakeholders to effectively combat COVID-19 pandemic.

The Smart Cities Mission, Government of India has extended technical support and very valuable inputs in terms of operationalizing the BBMP COVID-19 War Room during the last one month and has identified BBMP COVID-19 War Room as a Model War Room for 100 Smart Cities in the country. Predictive Modelling in collaboration with the Indian Institute of Science, Bengaluru is one of the deliverables from the BBMP COVID-19 War Room.

Therefore, it is directed to follow the due procedure and appoint a Nodal Officer for each activity / function identified below and furnish all the information on timely basis to the BBMP COVID-19 War Room:
