PREAMBLE:

The Government of Karnataka has been progressively working towards simplifying the business regulatory procedures in the State. The emphasis has been on the simplification of existing rules and the introduction of information technology for effective governance.

It has been perceived that the renewals of the Trade License by the businesses under the Karnataka Municipal Corporation Act create another layer of regulatory and cost burden to the businesses.

Further, the Ministry of Finance vide ref (1) has recommended states to simplify the existing licensing systems by the elimination of renewal procedure. However, a mere collection of reasonable fees with automatic non-discretionary deemed online transparent renewal is permitted. In the meeting ref.(2), Chief Secretary to the Government of Karnataka has also recommended introducing a transparent online system for auto-renewal of Trade licenses based one-payment of the applicable fee.

Accordingly, the Government of Karnataka has decided to introduce an online, transparent, automatic, and non-discretionary auto-renewal system without the requirement of any physical touch point for the Trade License issued by Urban Local Bodies.

In the circumstances explained in the preamble and exercise of the powers conferred under the Karnataka Municipal Corporation Act, the Bruhath Bengaluru Mahanagara Palike is pleased to hereby, introduce a transparent and online auto-renewal system for the Trade License henceforth.

The Trade License shall be auto-renewed based on the e-payment of the prescribed fee paid through the department portal. Under this provision, the applicant/businesses need not submit any separate application. The applicant can download the digitally signed approval certificate through the portal without any physical touch point with the department.

This shall be with effect from the date of publication of this order.
