EXPRESSION OF INTEREST

The Hon'ble Chief Minister of Karnataka in the 2017-18 budget speech announced on 15.03.2017 a novel programme to supply breakfast, lunch and dinner to the common man at affordable price. One canteen in each of 198 wards of Bruhat Bengaluru Mahanagara Palike will be opened, wherein breakfast at Rs.5 and lunch & dinner at Rs.10/- will be provided. The said canteens have been named as Indira canteen and in order to implement this program. It has been decided to open one centralized kitchen for every assembly constituency which will cater to wards in the constituency. BBMP is constructing necessary kitchens and canteens within its jurisdiction to cater to this project. All the kitchens and canteens will be fully equipped appropriately for preparation and catering. The Hon'ble Chief Minister has declared that the Indira Canteens will commence functioning from 15th August 2017.

In this regard Executive Engineer, (TEC) on behalf of the Commissioner, Bruhat Bengaluru Mahanagara Palike invites EOI from the reputed manufactures / suppliers of Kitchen/Canteen equipment as mentioned in Annexure.

Interested manufactures / suppliers may submit the EOI through the following method.

Scope of EOI:

- Interested parties who can supply all or any of the products as in the Annexure shall produce the following documents:
 1. Company / Firm details such as copy of registration, VAT/GST, Labour License.
 2. Experience / performance certificate in manufacture and or supply, installation and commissioning of kitchen equipment to big hotels / Restaurants / MNC / big hospitals and hostels etc.
 3. The Participants shall have minimum financial turnover of Rs.300.00 Lakhs in any 2 years during the last 5 years by enclosing certified Profit and Loss balance sheets.
 4. Participants may submit the details or all the items they can supply along with catalogues etc.

Mode of Implementation:

The Evaluation Committee of BBMP will scrutinize the documents submitted by the intending participants. BBMP shortlist eligible / capable manufacturers / suppliers. Subsequently, BBMP will call for Price quotations from the shortlisted manufacturers / suppliers.

Selection of successful bidder/s will declared and intimated to the concerned. BBMP reserves the right to accept or reject any quotations without assigning the reason therefor. BBMP reserves right to place supply orders on any one firm / company or choose more manufacturers / suppliers as per the specifications and requirements of BBMP.
