- Any reputed Individual / Company registered with BBMP/ KPWD /CPWD/Railways/MES / National Highway or any other equivalent central/state govt organizations are eligible to apply.
- Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in> under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>.

- Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).
- Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <https://eproc.karnataka.gov.in/>.

- The tenders shall be strictly submit as per the formats and terms and conditions specified in the tender documents. Lump sum tenders will not be considered. Separate tenders shall be submitted for each work.
- No Joint Venture / No Consortium are permissible.
- Non submission of the tender attracts action as per conditions stipulated in the rules of registration of Contractors.
- Conditional Tenders will not be accepted.
- Sub-letting of work is prohibited.
- The Tender will remain valid for 90 Days from the Date of Opening of Tender.
- "The rate/amount quoted by the Bidder is less than the rate/amount put to tender, such bidder shall remit the Difference Amount as per the KW1/KW2 Failure to comply with this condition, the tender shall be rejected and EMD amount shall be forfeited".
- In the unlikely event of any dispute pertaining to contractual terms and conditions, terms and conditions specified in standard tender documents (KW-1 to KW2 or any other applicable document) of Karnataka government shall prevail and binding.
- The applicant should upload the following documents in e-procurement portal

a. proof of registration.

b. Latest Income Tax Certificate & Sales Tax Certificate obtained from the concerned Department while submitting the Tender Schedules.

- All applicable state/central statutory tax/fees/deductions imposed by competent authority from time to time shall be deducted from the work bills.
- As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- 5 to 5½% of the bill amount along with other statutory deductions shall be deducted as FSD .
- EMD & FSD Amount will be returned after satisfactory completion of one year guarantee period from the date of satisfactory completion of the work.
- The successful bidder should submit Negotiation tenders within 3 days from the date of intimation.
- The successful bidder will have to execute an agreement with BBMP (within 7days from the date of Intimation) failing which his tender is liable to be rejected.
- The work should be commenced with all earnestness within stipulated time from the date of work order failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the tenderer.
- The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
- As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 the successful contractor shall engage workers registered in "Karnataka State Building & Other Construction Employees Welfare Board." Only
- The successful contractors those not registered in BBMP shall register in BBMP before entering in to Agreement.
- The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
- The work shall be executed by using quality material, directed by Engineer Incharge from time-to-time.
- The sample fittings and other accessories shall got approved from the competent authority
