Instructions & Conditions:

1. If the Beneficiary has A.P.L Ration Card and having Annual Income of Rs.0-3 Lakhs and has opted for Construction of House by himself/herself under PMAY, he/she is entitled to get only Rs.1.50 lakh Subsidy as per the guidelines of Government of India.
2. If the Beneficiary has B.P.L Ration Card falling under the category of SC/ST, he/she is entitled to get the Subsidy of Rs.3.30 lakh and the others are entitled to get the subsidy (as per the target allocated to urban areas by the Government of Karnataka) of Rs.2.70 lakh as per the guidelines of both Central and State Government.

3. If the Beneficiary has opted for extension of House under construction by himself/herself (One Room + Toilet/Bathroom) and the Annual Income is 0-3 lakh Rupees {Only having B.P.L/A.P.L Ration Card} , he/she is entitled to get only the Subsidy of Rs.1.50 lakh as per the guidelines of Government of India.

4. The Beneficiary should not be benefited previously from any other such similar Government schemes.

5. If it is found at any stage that the Beneficiary has given False Information or produced fake documents, Legal Action will be taken against such and the beneficiary is bound to the action whatsoever.

6. If the Beneficiary has understood all the above conditions and abide to them, he/she has to sign the form and submit.
